Haynes, George C. Adams, Charles H. Calloway, and L. Amasa Knox.



## Overview

The National Bar Association - Commercial Law Section's (NBA-CLS) 38th Annual Corporate Counsel Conference will be held February 20 - 22, 2025 at the El Conquistador Resort in Puerto Rico.

Drawing approximately 350 - 400 attendees each year, the Corporate Counsel Conference is designed to promote the mission of the Section by providing continuing legal education on a variety of substantive law topics, a law firm attorney/corporate counsel connections expo, signature panels, and wonderful networking, sharing, and learning opportunities for corporate counsel and law firm attorneys.

## Profile

In 1987, a small group within the NBA-CLS met to consider ways for NBA members in business practice to meet with institutional corporate clients for the purpose of developing professional relationships and to create opportunities for institutional entities to seek out, meet, and refer outside legal matters to African-American attorneys.

The inaugural Corporate Counsel Conference in 1988 was held in Chicago, Illinois, and proved to be a resounding success because it enabled major corporations to meet and network with NBA members who practice in areas of substantive law affecting America's major corporations.
